<u>Freedom of Information Act 2000 - Request for Information - NHS North East & North Cumbria Integrated Care Board.</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 03 March 2023 for information held by NHS North East and North Cumbria Integrated Care Board (ICB) under the provisions of the Freedom of Information Act 2000.

For information Clinical Commissioning Groups ceased to exist on 30 June 2022. Services that were previously delivered by the CCG are now being delivered by the successor organisation NHS North East and North Cumbria (ICB). This covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley.


Questions relating to the Cumbria Learning and Improvement Collaborative (CLIC)

- 1. How much has CLIC cost to run since its creation?
- 2. Who is CLIC accountable to?
- 3. How has CLIC documented the impact it has had?

Our Response

- 1. Typically the team have run with a VSM/8D senior lead (ave 0.8fte), one or two operational leads/practitioners bands 7-8c (1.0-2.0 fte), and admin resource at bands 3-4 (2.0 fte). Additional resource is derived from associate support from partner organisations and so is not part of the team established. The team operate with a small budget and rely on funding for special projects (for example AHSN fund our annual conference).
- 2. CLIC was established by Cumbria CCG in 2014. It is effectively a department within the CCG and the team work under the CLIC (Cumbria Learning and Improvement Collaborative) banner.
- 3. CLIC is now accountable to NENC ICB and work predominantly at 'place' serving health and care in North Cumbria and also the wider learning and improvement effort for the North East and North Cumbria ICB.
