Between 01/07/23 and 31/03/24 NENC ICB received 238 formal complaints about GP services

- 11. Between 01/04/24 and 31/03/25 NENC ICB received 679 complaints about GP services.
- 12. Responsibility for the management of complaints against primary care practitioners transferred from NHS England to NENC ICB with effect from 01/07/23. The ICB is therefore unable to provide complaints data for 2022/23. You may wish to redirect your request to NHS England using the contact details provided in the response to question 10.

Between 01/07/23 and 31/03/24 NENC ICB received no formal complaints about pharmacy services.

- 13. Between 01/04/24 and 31/03/25 NENC ICB received 25 complaints about pharmacy services.
- 14. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does receive complaints about hospital services. We would redirect them to the appropriate trust to be investigated and we do not hold data on the complaints each trust receives.

However, we have determined that full records are held by the acute and mental health hospital NHS foundation trusts (FTs) within the North East and North Cumbria region.
