## <u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 29 April 2024for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

## Your Request

Could you please let me know which primary care rebate schemes your ICB/ Health Board are currently signed up to?

Could you please provide the start and end dates of the contracts.

**To clarify:** A primary care rebate scheme is a contractual agreement with a company and an ICB (yourselves) that offers financial rebates on GP prescribing expenditure for branded medicines. In this instance, we would like to know which branded medicines you have agreements for, and when they started and ended.
