Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 3 July 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

If applicable, could you please confirm whether you intend to renew your contract with Docman for workflow services or if you are considering other providers?

If the latter, will the selection be made through a tender process or a specific framework?

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information requested.

Although 31 October 2024 is the GP IT Futures framework contractual end date for those services, the ICB has no intention of ceasing/terminating the contract, as there currently is no method of extending/renewing them, until such time as we have received national guidance on how to do so.

NHS England have asked the ICB to work collaboratively with practices and Primary Care Networks (PCNs) and the national Commercial and Procurement Hub to ensure the necessary

clinical system extensions are in place. However, they only refer to clinical system extensions in this guidance, and Docman is not a clinical system.

All procurements, when conducted by the ICB, are carried out in accordance with NHS procurement rules, from Public Sector/UK Government approved and accredited frameworks and are fully compliant with NHS England Standing Financial Instructions.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log. Therefore, a version of our response which will protect your anonymity will be posted on the NHS ICB website https://northeastnorthcumbria.nhs.uk/.
