The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Your Request

I am writing to request information under the Freedom of Information Act 2000.

The purpose of this request is to gather data on the number of children referred to weight management services.

Please provide the following information for your ICB area for the period 1 January 2024 to the most recent month available in 2025 (up to and including August 2025 if held):


- 1. The number of children and young people (under 18) referred to specialist (Tier 3) paediatric weight management services commissioned by your ICB.

 - a. If available, a breakdown by age group (e.g. 0-4, 5-10, 11-15, 16-17).
