**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 25 April 2024 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

**Your Request**

Please provide me with the method the ICB has devised to enable misconduct that effects patient's patient centred care, to be reported and recorded.

**Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

We have no process within the ICB that looks at misconduct that effects patient's patient centred care.

Within each provider there are HR policies/ procedures including ones that cover professional practice concerns such doctors in difficulty and freedom to speak up. Where misconduct occurs, it is the duty of the provider or professional regulators to respond. Where misconduct relates to

board members of NHS trusts this is the responsibility of the Care Quality Commission to assess compliance with fit and proper person regulations and NHSE to support trusts to take action.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for acute and mental health hospitals in North East and North Cumbria.
