<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received by North of England Commissioning Support (NECS) on 08/09/2023 for information held by NHS North East and North Cumbria Integrated Care Board (NENC ICB) under the provisions of the Freedom of Information Act 2000.

NENC ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland and Tees Valley (which covers the 5 councils that make it up – Darlington, Hartlepool, Middlesbrough, Redcar & Cleveland and Stockton-on-Tees).

- 5. In the financial year 2019/20, how much money did the ICBs pay to general practices to fit LARCs?
 - a. What channel was this predominately paid via (i.e., LES/LCS)?
- 6. How many general practices were able to offer LARC fittings in 2019/20?
- 7. How many LARC fittings were made in general practice in your ICB in 2019/20?
- 8. What was the prescribing rate for LARCs in general practices in your footprint in 2019/20?
- 9. How many general practices fall within your remit?
- 10. What was your total patient population for 2022/23?
