<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North</u> <u>Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received on 1 May 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I am writing to you under the Freedom of Information Act 2000 to request the following information.

Please may you provide me with data on the number of people who have had their funding for NHS Continuing Healthcare withdrawn. I would like the data broken down for the most recent five years, with a year-end date of 5 April or whichever year-end is most convenient.

If this cannot be provided, I would like the annual data for the last three years or, failing that, the most recent two years. If you can identify any ways that my request could be refined, I would be grateful for any further advice and assistance.

To clarify:

- 1. I am requesting information on full CHC funding.
- 2. The response should cover all localities.
- 3. By withdrawn, I mean deemed ineligible for further funding following a review and moved to self-funding
- 4. If possible, it would be good to have examples of different reasons for funding removal.
