- National Institute of Health and Care Research The i4i Programme is a translational research funding scheme aimed at de-risking early-to-late stage medical devices, in-vitro diagnostics and high-impact patient-focused digital health technologies for ultimate use in the NHS or social care settings. Contact Angela for information regarding calls for funding (due by 10th October).
- Faster Data Flows (FDF) a two-year pilot is underway, with NENC providers who are already submitting to CSDS being approached to support onboarding
 - You can find out more about Community FDF on the <u>FutureNHS</u> workspace, including an outline of Faster Data Flows and the benefits this will bring to the NHS and patient care.
- Wayfinder and e-RS funding: For 25/26 we are now required to generate a 1-year addendum business case to enable continuation of the programmes for 1 year (this applies to both e-RS and Wayfinder). The ambition to expand Wayfinder to Community and Mental Health Trusts remains consistent with our original plan.
 - As some of you will be aware, there are fast moving discussions taking place on 'one digital estate'
 (ODE) and shaping a future investment proposal for EPRs.
 - o Is bringing in a new EPR suppler into the market the right approach for community services?
